Pursuant to S.10 of the Tanganyika Law Society Act, CAP 307 R.E and S. 31,34-36 of the Advocates Act, CAP 341 R.E 2002, please be advised that the Tanganyika Law Society Annual Subscription fee for the year 2019 range from TZS 115,000/= to 520,000/= depending on the number of member's years of practice. Additional contribution include optional membership fee for East Africa Law Society (EALS) which is in two categories (**US\$20 for members with less than 5 years of practice and US\$40 for members with 5 and above years of practice**), TZS 40,000/= for the Deceased Advocates Trust Fund (DATF) and TZS 400,000/= for the Legal Aid Advocacy Centre (LAAC) – Wakili house *"Once to Go initiative"*
