Pursuant to S.10 of the Tanganyika Law Society Act, CAP 307 R.E and S. 31,34-36 of the Advocates Act, CAP 341 R.E 2002, please be advised that the Tanganyika Law Society Annual Subscription fee for the year 2020 range from TZS 120,000/= to 520,000/= depending on the number of member's years of practice. Additional contribution include optional US\$ 10 to US\$ 40 membership fee for East Africa Law Society (EALS), TZS 40,000/= for the Deceased Advocates Trust Fund (DATF) and TZS 200,000/= for the Legal Aid Advocacy Centre (LAAC) – Wakili house *"Once to Go initiative"*.
