NOTICE IS HEREBY GIVEN THAT in accordance with Sections 15(1), 19(2) (d), and 21 of the Tanganyika Law Society Act Cap 307 as amended, the TLS's Annual Conference; General Meeting for holding the Society's General Elections; and the Annual General Meeting of the Tanganyika Law Society shall be held at the **Arusha International Conference Centre (AICC) in Arusha on Thursday, 25th to Saturday, 27th June, 2020.**

The Society's Annual Conference will be held on **Thursday, 25th June, 2020 from 08.00AM to 01.00PM.**

The Society's General Meeting will commence from **02.00PM to 06.00PM on Thursday, 25th June, 2020** and will continue on **Friday, 26th June, 2020 from 06.00AM to 05.00PM.**

The Society's Annual General Meeting will be held on **Saturday, 27th June 2020 from 09.00AM to 04.00PM.**

The Theme for the Annual Conference will be ***"Electoral Justice: The Role of Lawyers in the Elections Process."***

The Society Annual Conference; General Meeting and the Annual General Meeting will be preceded by **series of CLE Seminars and discussion forum** to be conducted within Arusha City from **Monday, 22nd to Wednesday, 24th June, 2020**. More details about the said seminars and the fora will be communicated to members through emails.

Each member shall bear his/her own costs for accommodation and transport. Members who will not be able to attend are required to appoint Proxies. All proxy forms shall be **duly signed and affixed with Revenue Stamps of TZS 500, and must reach the TLS Secretariat three days before the date of the Meeting - forms received after 22nd June, 2020 will not be accepted.**

*N.B: There will be an **Exhibition** from **Monday, 22nd through to Saturday, 27th June, 2020** which will involve law firms, paralegals, judiciary, key governmental departments, like minded organizations and other stakeholders.*
