# CANDIDATES SELECTED TO CONTEST FOR VARIOUS POSITIONS AT THE TANGANYIKA LAW SOCIETY ELECTIONS FOR 2021.

Rule 3 of the Tanganyika Law Society (Elections) Regulations GN No. 526 of 2020 empower the Council of the Tanganyika Law Society to establish an Electoral Committee.

The Electoral Committee issued a call for nominations on  $03^{rd}$  February, 2021 through TLS official email, Daily News and the Citizen Newspaper. The nomination submission ended on  $16^{th}$  February, 2021. The Electoral Committee extended the period of nomination to  $25^{th}$  February, 2021 to allow for additional nominations due to the fact that there were no sufficient candidates to enable it proceed with vetting.

One of the functions of the Electoral Committee is to examine and vet the TLS members who are nominated to contest various leadership positions after satisfying itself that such members meet the eligibility criteria prescribed in the TLS election regulations for the position they wish to stand for.

Following the closing of the extended period, the Electoral Committee met on  $03^{\rm rd}$  and  $04^{\rm th}$  March, 2021 for vetting process as per Rule 25 of the Election Regulations GN 526 of 2020. Rule 26 of the TLS Election Regulations GN 526 of 2020 requires the Chairperson of the Electoral Committee to send to every members of the Society the names of all candidates eligible to vie for election.
