RE: ANNUAL SUBSCRIPTION FEE NOTICE – FINANCIAL YEAR 2023

Pursuant to S.10 of the Tanganyika Law Society Act, CAP 307 R.E and S. 31, 34-36 of the Advocates Act, CAP 341 R.E 2002, and AGM 2022 resolution, please be informed that the Tanganyika Law Society Annual Subscription fee for the year 2023 ranges from TZS 100,000/= to TZS 250,000/= **(divided by 30% to the member's Chapter and 70% to Head Quarter)** depending on the number of member's years of practice. Additional contribution include US\$ 20 membership fee for East Africa Law Society (EALS), TZS 50,000/= for the Deceased Advocates Trust Fund (DATF) and TZS 200,000/= for the Legal Aid Advocacy Centers (LAACs) – Wakili house **"Once to Go initiative"**.

Further, Pursuant to Third Schedule of the Notaries Public and Commissioners for Oath Act, CAP 12 as amended by the Act No. 2 of 2016, please be advised that Judiciary fees for the year 2023 range from 90,000/= to 140,000 depending on the number of years of practice per individual member.
