

**A MOTION FOR REFORMS OF MEMBERS' AFFAIRS WITHIN THE  
TANGANYIKA LAW SOCIETY:**

**FROM: ADV. BONIFACE A. K. MWABUKUSI; A MEMBER OF THE  
TANGANYIKA WITH GOOD STANDING, ROLL NO.1571.**

**TO: ALL MEMBERS OF THE TANGANYIKA LAW SOCIETY WHO  
WILL ATTEND ANNUAL GENERAL MEETING TO BE HELD AT  
DODOMA ON 1<sup>ST</sup> TO 3<sup>RD</sup> AUGUST, 2024.**

**WHEREAS:** I, Advocate **Boniface A. K Mwabukusi**; a Member of Tanganyika Law society with good standing used my right as TLS member with qualifications to contest the position of TLS President in the election to be held this year;

**WHEREAS:** The Electoral Committee of TLS found me together with other five TLS members with all qualifications and hence eligible to contest the position of TLS President for year 2024/27;

**NOW THEREFORE:** I present this Motion before the Annual General Meeting of Tanganyika Law Society to be held at Dodoma on 1<sup>st</sup> to 3<sup>rd</sup> days of August 2024 in the following terms;

**PRIORITY OF THIS MOTION:**

It is kindly requested that this Motion should be accorded **A VERY HIGH PRIORITY TO BE ONE OF THE MOST TOP IN LIST OF AGENDAS** of the Annual General Meeting and it should be discussed on a **FIRST DAY** of the Meeting, in the **MORNING**.



**1. TO RESTRAIN FROM HOLDING THE ELECTION OF TLS PRESIDENT UNTIL THE NAME OF BONIFACE A. K.**

**MWABUKUSI IS RESTORED AS ONE OF THE CANDIDATES:**

THAT among the key obligations of TLS are to promote unit, equality, non-discrimination, human rights, integrity, legal fraternity, curtesy, members' welfare etc among TLS Members. TLS being a statutory Board of Profession, all Advocates shall protect its existence, prosperity and ensuring unit, stability and relevance of the Bar to the Society so as to be a respected Professional Board within Tanzania people. Hence Members of TLS must be treated fairly, equally and without any discrimination.

THAT after being nominated and passing all stages all over, suddenly and without any justification whatsoever, the Electoral Appeals Committee of TLS unlawfully, illegally and without jurisdiction disqualified me from being the candidate of TLS Presidential election this year based on baseless grounds. I believe that the removal of my name from being one of TLS Presidential candidates has prejudiced my right as a member of TLS with good standing since the decision was manifested with intentional injustice to me, impunity, biased and illegality as well and the Committee exceeded its power vested on it.

Brothers and Sisters let together stand for justice to all, let us not cherish injustice to any of us. Today is me tomorrow is you. Let us bring back TLS to be a respectful Professional Board in the Region.

**RESOLVE THAT, to restrain from holding Election of TLS President until the name of BONIFACE A. K. Mwabukusi is restored as one of the candidates of the position of TLS President this year, 2024.**

**2. DISSOLUTION OF TLS ELECTORAL APPEALS COMMITTEE:**

The decision of the Electoral Appeals Committee of TLS which was unjust, biased, unfair, discriminatory, full of injustice, illegality and impunity has put TLS to be a SHAM, disrespected and hopeless Society before the Tanzanians and East Africa Region at large and that further the decision has unnecessarily and may be intentionally divided members of TLS.

**RESOLVED THAT; THE ELECTORAL APPEALS COMMITTEE OF TLS be dissolved with immediate effect for want of integrity.**

**THEREFORE;** It should be Resolved that:

- i. TLS Presidential Election of 2024 be restrained until the name of **BONIFACE A. K. MWABUKUSI** is restored as one of the candidates.
- ii. The Electoral Appeals Committee of TLS be dissolved for want of integrity.
