



## **CONSULTANCY- TERMS OF REFERENCE (TORs) TO DEVELOP CONTENT ON GENDER BASED VIOLENCE**

### **BACKGROUND INFORMATION**

Tanganyika Law Society (TLS) is a statutory professional organization established by an Act of Parliament - the Tanganyika Law Society Ordinance of 1954. Currently TLS is governed by the Tanganyika Law Society Act, Cap 307 as amended.

One of the core components of TLS statutory mandate is to assist the Government, Judiciary and Parliament in all matters affecting legislation, and the administration and practice of the law in Tanzania. Other TLS statutory mandate include; to facilitate the acquisition of legal knowledge by members of the legal profession and others, to protect and assist the public in Tanzania in all matters touching, ancillary or incidental to the law, and to represent, protect and assist members of the legal profession in Tanzania as regards to conditions of practice and otherwise.

TLS is contributing to the implementation of the Mama Samia Legal Aid Campaign aiming at Promoting access to Justice for vulnerable groups in Tanzania. Currently, TLS is partnering with GIZ Tanzania and other justice stakeholders such as MoCLA, UDOM Legal aid Clinic, and paralegal organizations in Dodoma and Tanga to implement a project that focuses on Legal aid services more broadly on and specifically legal aid services for gender-based violence (GBV). This is a comprehensive initiative which aims at eliminating GBV within Dodoma and Tanga regions and strengthening women's and children's rights more broadly. Its primary objectives is to create safer and more equitable environment for all individuals irrespective of their gender

3. Develop content on Gender Based Violence for awareness raising program to community leaders including LGAs, Small entrepreneur groups led by women, youth and PWDs
4. Submit the compiled document of the above contents
