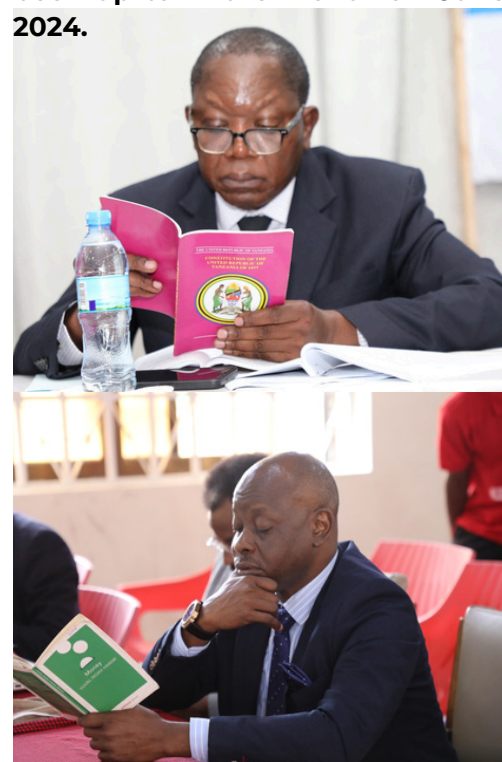

COMPULSORY INDUCTION SEMINAR FOR THE NEWLY ADMITTED ADVOCATES, JUNE 27, 2024

TLS, in collaboration with the Judiciary of Tanzania, conducted the compulsory induction seminars for the newly admitted advocates, who will be admitted to the bar on Wednesday, July 3, 2024, at the Mwalimu Nyerere Convention Centre. The induction seminar was conducted at the Law School of Tanzania on June 27, 2024.

In his opening remarks, the Vice President of Tanganyika Law Society, Senior Advocate Deus Nyabiri said, "As you are about to join our noble profession, we are happy to have you as members of the Bar Association. You should take pride in all of the accomplishments that have brought you to today. We all know what tremendous effort it takes to complete Law School and pass the exams. As soon as the Chief Justice admits you, you will be licensed to practice law on the Tanzanian mainland. With this authority comes responsibility, and always remember that the law is about service and the commitment to serve."



550 Newly Admitted Advocates were oriented on the dos and don'ts of the legal fraternity, the Tanganyika Law Society, and Judicial compliance. Among the TLS areas of concentration were knowledge about TLS, knowledge about the East Africa Law Society, Professional Ethics and Etiquettes for Lawyers presented by Advocate Ally Kileo, a member of the TLS' National Ethics Committee, and Continuing Legal Education (CLE) presented by the Chairperson of the TLS' National CLE Committee, Adv. Simon Patrick.

They also learned about the functions and operations of the Deceased Advocates Trust Fund (DATF) presented by DATF Board Member Senior Advocate Jessie Mnguto, Advocate Remuneration and Billing presented by a member of the Welfare and Remuneration Committee, Adv. David Saire Manoti and the Tanzania International Arbitration Centre (TIAC) shared knowledge about its membership and functions.



Also, TLS provided to the Newly Admitted Advocates with knowledge on the use of TLS ICT systems such as the Wakili database, Wakili stamp, CLE seminars, Annual Subscription Fees, TLS website, TLS social media, and the Wakili TV channel.

On the other side, the Judiciary of Tanzania oriented them on Professional Conduct and Etiquettes: Advocates Duty to Court, Introduction to Remote Proceedings and e-filing, An Overview of the e-case Management System (e-CMS), and Effective Use of E-Wakili, especially Bills, Payments, and Other Advocates' Permitted Applications.

OVERVIEW OF THE IMPLEMENTATION OF FREEDOM EXPRESSION PROJECT ACTIVITIES FOR THE MONTH OF JUNE 2024

Freedom of Expression is a project funded by the American Bar Association – Rule of Law Initiatives (ABA ROLI). The intervention was designed to strengthen freedom of expression (FOE) among the society by bringing together the key players and increasing awareness of the targeted group on issues about the Right to Freedom of Expression

The objective of the intervention is to;

“Enhance capacity and coordination of Media, Civil Societies, and Legal Sector actors to advocate for the Right to Freedom of Expression”

During this month, two Capacity building sessions were organized and successfully run. The training was;

- Capacity building session to Media personnel on which 20 media personnel were brought together in Dodoma and training on issues about the Right to Freedom of Expression
- Capacity building session for Legal Practitioners (Advocates) on which 20 advocates were trained on issues about the Right to Freedom of Expression.



OVERVIEW OF THE IMPLEMENTATION OF CONSTITUTIONAL REVIEW PROJECT ACTIVITIES FOR THE MONTH OF JUNE 2024

Constitutional Review Process is a project funded by Open Society Foundation. The project was designed to engage different people of the society so as to collect comments or opinions in regards to the Constitutional Review Process in Tanzania.



The objectives of the project are,

- To advocate for peoples' driven Constitution to the current context that addresses the present legal gaps in institutions
- To offer an avenue that will allow citizens to voice their opinions, concerns, and suggestions regarding the new Constitution



Under the project the following activities has been successfully conducted during the month of June 2024:

- Five public debates brought together various groups within the community such as Lawyers, CSOs, Farmers, miners, fishers, live stokers, tour operators, political parties, engineers, accountants, Doctors, other professions, university students, business people, entrepreneurs, media, Faith Based Organisation, people with disabilities Diasporas and other people from the community. In the month of June 2024, the debates were conducted in Arusha, Mbeya, Dar Es Salaam, and Dodoma
- Three consultative sessions with the special group brought together People with Disabilities, Women, and Youth from universities
- One consultative session with Constitutional Experts brought together various people with experts on Constitutional matters to discuss, analyze, and give their insight on the Constitutional Review Process in Tanzania



Through the above activities, TLS was able to collect opinions regarding the Constitutional Review Process in Tanzania.

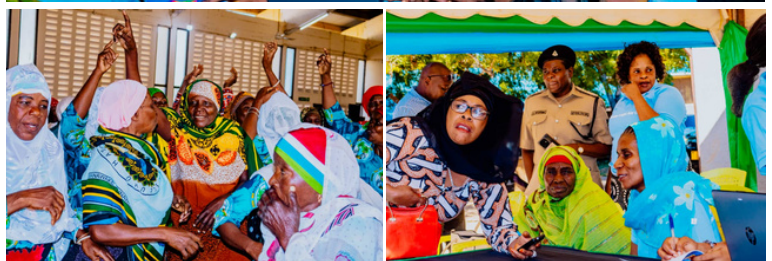
